Review report to PROMACT PLASTICS LIMITED (formerly known as Promact Impex Limited).

We have reviewed the accompanying statement of unaudited standalone financial results of **Promact Plastics Limited (formerly known as Promact Impex Limited)** for the period ended **31st December, 2025** ("the statement"), being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements), 2015, as amended ("the Listing Regulations").
